You may opt out from our sharing information with these non-affiliated third parties by notifying us at any time by telephone, mail, fax, email, or in person.

CommonWealth maintains a secure office to ensure that your information is not placed at unreasonable risk. CommonWealth does not provide your personal information to mailing list vendors or solicitors.

CommonWealth requires strict confidentiality in our agreements with unaffiliated third parties that require access to your personal information, including financial service companies, consultants, and auditors. Federal and state securities regulators may review our company records and your personal records as permitted by law.

We will maintain personally identifiable information about you while you are a client, and for the required period thereafter that federal and state securities laws require.
